ALCO HILL by John David Finl

Alco Hill was owned by my maternal grandfather, N. R. Leigh, Probate Judge of Escambia County for 24 years. My mother, Katie Leigh, owned it next and gave it to me before her death in 1929. I am the third generation to own this property but the first to live on it. The home was built in 1941.

The two columns on the lower drive have terra-cotta pieces and two heads from the court house erected in 1901 which was torn down in 1961. The head on the left of the drive, going up, according to The Library of Congress, is of Antonius Pius, a Roman Emperor, and that on the right is Micholangolo, Italian artist, whon he was a young man.

A path on the East edge of the woods leads to traces of trenches used in fighting Indians. A fight with the Indians took place on Alco Hill. (Read of the incident in September, 1973 Quarterly, page 20).

On the northeast edge of the woods is a Torii. Shintoism is based on nature worship and the Torii was used as the entrance to a shrine to keep out oul spirits. We call our woods the shrine.

The northwest corner of the lawn is a path with two Foo Dogs at the top. The path leads down to a Japanese Garden with a reflecting pend. The bridge and the wooden lantern were taken from a Japanese print. On the path across the pend is a stone lantern carved in Japan.

Our son, John David, Jr., spent half of three years at Yokosuka, Japan which was the home port in Japan of the aircraft carrier USS Oriskany, CVA 34. He was an officer on this ship. He sent or brought us many things from Japan during those three years, and get us deeply interested in oriental art.

The round stone table is a mill-rock.

By the tennis court I have erected a fossil wall from beautiful pink limestone from Thomas McMillan's ranch, Jay Villa, in Conecuh County. This rock is filled with fossils of sea life dating back about 70 million years when under the sea.

There are a number of rare trees from many parts of the world growing on Alco Hill.

On the second floor of the home, a former playroom, at the suggestion of my wife Emily, is now a museum. I think you would be interested in looking at the varied items in it which I have collected.

To the right at the tope of the lower drive is a road leading to John David, Jr.'s home. The architecture of this home is unusual. He will welcome you to his home also.

We look forward to sharing with you on Alco Hill, the second annual garden party held by the Escambia County Historical Society.
