PETER LAZARUS JOHNSON - His Song by Ronald A. Stratton

Peter Lazarus Johnson was born in Conecuh County, Alabama, March 12, 1828 to pious and prominent farm stock. He was one of four brothers and one sister--children of William B. Johnson and the former Elizabeth Parker.

William B. Johnson and his brother, Washington Johnson, arrived in Conecuh County in 1818 from South Carolina and established a farm on land north of Evergreen near the Chapman place.

Elizabeth Parker, Peter's mother, has revolutionary service in her family history. Elizabeth was granddaughter of John Parker of Sussex County, Deleware, and later of Hancock County, Georgia. John Parker was born September 25, 1740 and died in Hancock County March 3, 1793. His war service is well documented in the Deleware archives department. His daughter, Mary, born August 20, 1774, married her cousin, Samuel Parker, and the family moved to Conecuh County from Hancock, Georgia before 1820.

Peter Lazarus Johnson's brother, Samuel C. Johnson (1821-1900) was educated at Howard College at Marion, Alabama (now Samford University), served in the Baptist ministry in Georgie, Florida, Alabama and Texas. He served with the Texas Rangers in the Mexican campaign and in 1894 published a book entitled "The consistency and Harmony of Election, Predestination and the Accountability of Man." He died in Angelina County, Texas.

Another brother, George N. Johnson (ca.1830-1864) was a victim of Civil War Service. He was wounded in the Ridge Battle in Tennessee, taken prisoner, and died June 9, 1864 while a prisoner of Union forces at Rock Island, Illinois.

The fourth brother in this family was William W.Johnson who lives in Conecuh County until his death. He was a member of the Conecuh Guards and was wounded in the Gaines Farm Battle , subsequently receiving a state pension.

Pater's sister, Mary Johnson, married John Diamond of Conecuh County and the couple moved to Santa Rosa County, Florida, raising a large family.

The apparent piety of the entire Johnson family was likely attributed to the influence of the Rev. Alexander Travis who ministered the Missionary Baptist Church at Evergreen for many years. Peter Johnson made his "good confession" and became a member of the church at the age of 12 and was baptized by Rev. Travis.

On November 4, 1852 Feter married the widow Caroline Elizabeth Murray. formerly Pugh, of neighbor Monroe County. She was daughter of William and Sarah Pugh. William Pugh's will is on file in the Court house of Monroe County.

In 1854 Peter and his family moved to Panola County, Texas with \$7 in his pocket and became a well-known citizen whose activity in community and church affairs is well documented. His homestead was near the tiny south Panola County community of Woods: His children were George P., Saray, William, Laura, Henry, and Samuel.

He served in the Confederate Service in the 7th regiment of the Texas Calvary, serving two years as a Lieutenant, before being captured at Camp Fratt and interred at the Rampert Street prison.

His years near the Woods community in west Texas are distinguished by many acts of civic involvement which undoubtedly led the Panols Watchman newspaper to chronicle his life in glowing terms saying "A good citizeh... pioneer...generally found working shoulder to shoulder with the best element of society...and note their passing with reverence."

He is credited with forming the neighborhood's first Sunday School in 1855 and joined with others in establishing the Independance Baptist Church at Woods the following year.

He was a long time Mason, helped to organize the South Panola Agri-Culture Society, was an original member of the Eureka Grange, was president of the Grange Association of Panola County, served a term as County Commissioner, Superintended the Grange Store at Teneha for many years, taught school, served as secretary of the community church, was an active debater, and was active in the Buena Vista and Shelby County Associations.

Peter Lazarus Johnson died October 31, 1904 at Woods and he is interred in the Old Center Cemetery.
