# A TRIBUTE - THOMAS E. McMILLAN Historian, Preservationist, Benefactor

Most everyone who knew Mr. Thomas E.McMillan intimately knew him as a very vivacious person, so full of life that the news of his death was met with shock and disbelief. He lived life to its fullest. He loved people and was loved by many. His untimely passing took one we will sorely miss and will always remember for his interest and generosity in all of this Society's endeavors. He served on the committee

to draw up the by-laws of this Society, and although he disapproved of our "Sowell House Project" paid the cost to move the house to the college campus and met with state restoration experts on several occasions regarding the restoration of the house. When our first garden party was held at The Leigh Place in 1973 Mr. McMillan was most generous in furnishing smoked turkey, several tubs of boiled shrimp and several kegs of draft beer in addition to the expense of putting up an outdoor shelter for the occasion. In 1975 he opened his home and The Leigh Place for the Alabama Historical Association Pilgrimage to Brewton. Then in June 1976 he and Mrs. McMillan hosted our Bi-centennial Martha and George Washington Party. Two of our fall Pilgrimages have been to historic Jay Villa Plantation in Conecuh County. The McMillan's have always been genial hosts and happy to have our group as their guests. Mr. McMillan received a 1976 Award of Merit from the Alabama Historical Commission and for two years was nominated by this Society for Alabama Historical Commission Distinguished Service Award but, much to our regret did not receive the award. The following is a citation prepared December 1, 1975 in connection with the 1976 Award of Merit:

"Thomas Edward McMillan has had an interest in history almost from the time of his birth when his diaper was pinned with his father's jeweled DKE pin and a gold coin was placed in his hand by a close relative, although he has not been content with hearing and reading about things past; he has wanted to "go and see" and felt disappointment on being told that there was nothing left, that all evidence had been destroyed.

"Thomas E.McMillan was born July 10, 1912, into a fmily whose roots are firmly embedded in Escambia County, Alabama soil. His mother, Iva Lee Miller McMillan, was daughter of T.R.Miller founder of the T.R.Miller Mill Company and for whom the local T.R. Miller High School was named, and his father, Ed Leigh McMillan, was son of Sheriff E.S.McMillan who was killed in the line of duty by the notorious outlaw, Railroad Bill. His wife, the former Elvira Minge Cochrane of Tuscaloosa, has shared his interest in historical preservation.

"When Mr. and Mrs. Thomas McMillan built their present home they attempted to build it around the old Blacksher home that stood on the site, but were confronted with so many building problems that they had to remove the old home.

"As a young man in the late 1930s he seized the opportunity to acquire several adjoining plantations near old Sparta in Conecuh County, all of which were rich in the annals of Conecuh County history—the Warren Plantation where Hinchie Warren, the first white man to cross Murder Creek made his home, where William Barret Travis of Alamo fame lived in his boyhood, and where in 1861 the Conecuh County Volunteers assembled; the Rube Millsap Plantation where Rev. Andrew Jay, one of the first sawmill operators and one of the first large planters of the area held the original land grant; also the Walter Lee, Lawrence, Crosby and Yarborough Plantations were acquired, making up an area of 6,000 acres. The old Warren plantation house and barn and Jay Villa post office building have been preserved for posterity by Thomas E.McMillan.

"After the death of his great aunt, Mrs. John D.Leigh, in 1967, her home which was formerly Brewton's first courthouse building,

was offered for sale and Mr. McMillan who had long admired its beautiful architecture and history, became the purchaser, naming it The Leigh Place because of his Leigh family connections. Mr. McMillan's pride in the history of the building is evidence by the great care he took in restoring the building to a place of beauty and importance. He always gives a warm welcome to visitors to The Leigh Place, as well as graciously hosting the Escambia County Historical Society's 1973 Garden Party at The Leigh Place, and opening it for the 1975 Pilgrimage to Brewton of the Alabama Historical Association where the reception for the visitors was also held. Mr. McMillan's great-grandfather, Norvelle R. Leigh, former Confederate Captain and Probate Judge of Escambia County, Alabama, and his grandfather, E.S. McMillan, former Sheriff of Escambia County, Alabama, both had offices in The Leigh Place during its "courthouse period."

"Mr. McMillan is a charter member and Trustee of The Escambia County Historical Society, and has distinguished himself in many fields of endeavor, being simultaneously director of T.R.Miller Mill Company and First National Bank of Brewton, and Neal Land & Timber Company of Blountstown, Florida, owner of McMillan Mill Company, partner of AlaFlora Forest Products, President of Southern Title & Abstract Company. Since graduating from the University of Alabama law school he has associated himself with his father in the practice of law and served as Secretary and General Counsel of the T.R.Miller Mill Company since 1950. He has been active in the Gulf Coast Council, Boy Scouts of America for many years, serving as a Vice President, and receiving the coveted "beaver" award for his contributions to the field of scouting. Through his cattle operations at Jay Villa Plantation he has served as Vice President and Director for Alabama Polled Hereford Association, director of Southeastern Polled Hereford Association, and is a member of the National, State and county Cattlemen's Associations.

"Mr. McMillan's efforts in the field of historical preservation are outstanding and are greatly appreciated by the people of this area, as well as by The Escambia County Historical Society.

"Both Jay Villa Plantation and The Leigh Place have been listed on the Bi-Centennial Trail."
