DEDICATION POSTPONED - Notice was sent with the December, 1978 quarterlies that it was necessary to postpone the dedication of the Fine Arts Building and Thomas E. McMillan Museum because commitments by the contractor for the building had not been fulfilled. Announcement will be made when the date is set up again.

THE NEW MAN IN TOWN - AN AVENUE OF CONCERN - Dr. George McCormick, the new President of Jefferson Davis State Junior College as of January 1st has made some overt changes in the college here, notifying three of the instructors that their contracts would not be renewed, stating lack of state funds because of lower student enrollment and that these instructors had classes where enrollment was too low to offer the classes, also stating that all teachers in the system now have to have Master's degrees. The Curator for the Thomas E. McMillan Museum, Roger Anderson, was one of the instructors, and Mr. Anderson will no longer be with the college after March 1st. Dr. McCormick has set up a Thomas E. McMillan Museum Advisory Council with the following persons on the Council: Mrs. Thomas E. McMillan, Jr., Chairperson; Mrs. J.D. (Gladys) Byrd, Mrs. Alice Till Beall, Mrs. Robert (Emily) Smith, Mrs. James E. (Patricia) Hart, Jr., Mrs. Earl H. (Sandra) Weaver, Mr. Hermione Holzborn, and Lee Bain; and has asked the council to make the following recommendations to him regarding the following items:

- 1) To develop a tentative budget for personnel and activity expenses and to insure the appropriate use of the dividends from the Trust.
- 2) To develop a tentative operating schedule for the museum.
- 3) To develop a tentative plan for staffing the museum.
- 4) To develop a tentative schedule of activities, events, and exhibits for the coming year.

While we might not agree with Dr. McCormick's actions regarding the museum we have to try to understand his position and hope that once he gets to know all the wonderful-concerned people in this part of the state and in this Society, and those who have brought the museum to its present stage, he will know that our only intention is to make the Thomas E. McMillan Museum the finest museum and archives for historical and genealogical research in this area. If he has the best interest of the college at heart, he can't be at cross purposes with The Escambia County Historical Society. We must work together to bring his intentions into focus with ours and help him to understand what has gone on before he arrived in Brewton, and all will be well.

NOW, A WORD IN PRAISE OF ROGER ANDERSON. Few have ever embarked upon a task with as much enthusiasm as did Roger Anderson. He is a man of immeasurable resourcefulness and energy and he put his "all" into the setting up of the museum. The display cases were designed by him and with Mr. Woodfin Patterson's guidance he furnished the museum in 1850 to 1880 period decor. Mr. Patterson had asked him to work closely with the Society in carrying out its wishes regarding the museum which he did. He has done an excellent job of setting up the displays and gathering the Society's collections into the museum building from the sundry storage places, selected items from Mr. Ed Leigh McMillan's collections, and has been in the process of cataloging and indexing the reference materials. It was through Mr. Anderson's efforts that the Escambia

County Commission agreed to move the old newspaper records and county records to the museum. As an active member of The Escambia County Historical Society Mr. Anderson has taken much of his free time to help with the Society's projects such as the Jefferson Davis Ball held last June, preparation of the float for the Christmas Parade, and assisted in getting the Quarterly publications up to date. His talents are innumerable and he is an excellent genealogist. In fact, we know of nothing he can't do well. We are sorry to lose him just as the museum was beginning to take shape. We will all want to express to him our heartfelt thanks for his efforts in our behalf and on behalf of the museum. He didn't just go the extra mile, as was the custom in Biblical times, but went two, three and four extra miles and exuberantly! A letter from him to you is attached to this newsletter. We wish him well in whatever he undertakes to do in the future.

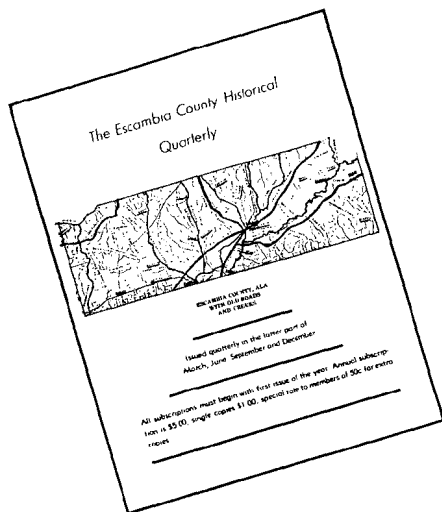

Dear Members:

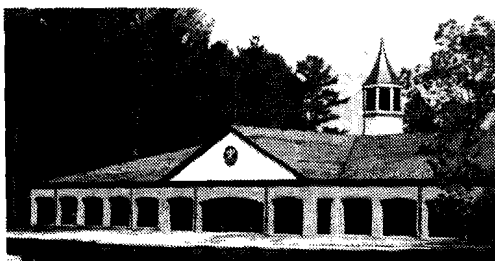
