ARTICLES OF INCORPORATION OF THE ESCAMBIA COUNTY HISTORICAL SOCIETY

STATE OF ALABAMA ESCAMBIA COUNTY

KNOW ALL MEN BY THESE PRESENTS: that the undersigned desiring to form themselves into a non-profit corporation under the laws of the State of Alabama, for the purposes hereinafter set forth, do hereby make and subscribe their names to these Articles of Incorporation.

ARTICLE I: The name of the corporation shall be "The Escambia

County Historical Society."

ARTICLE II: The period of duration of the corporation shall be perpetual.

ARTICLE III: The purposes of the corporation shall be:

Section 1: To search for, collect, preserve, and publish any and all materials, artifacts, fossils, and items of historical significance pertaining to the people and area now known as Escambia Couty, Alabama, found to be desirable by the membership, whether it be of a general nature or relating to specific families, churches, businesses, etc.

Section 2: To assist in and encourage the erection of a museum or other permanent place to house all information, artifacts, fossils and materials collected, and to display such items collected as well as to hold and display for private collectors any items said private collectors might wish to loan or consign to said museum or permanent place.

ARTICLE IV: The corporation shall have all powers of non-profit corporations as provided in the "Alabama Non-Profit Corporation Acts" including, but not limited to, the power to hold, preserve and dispose of both real and personal property, and to conduct fund raising acti-

vities for the purposes set out above.

Any income received by the corporation shall be applied only to the non-profit purposes and objectives of the corporation as set out herein, and no part thereof shall inure to any private member or individual.

The corporation shall not engage in any transaction prohibited by Section 503 (c) of the United States Internal Revenue Code as now enacted or as it may be hereinafter amended, or the "Alabama Non-Profit Corporation Act."

The corporation shall not apply accumulation or income in any manner which may subject it to denial of exemption as provided in Section 504 of the United States Internal Revenue Code as now enacted or as it may be hereinafter amended.

ARTICLE V: Membership in this organization shall be by invitation and/or application in accordance with the By-Laws of the Society.

ARTICLE VI: The officers of the corporation shall consist of a President, Vice-President, Librarian, Secretary, Treasurer, Publicity Chairman, and Historian/Curator. Each said officer shall be elected or appointed at such time and in such manner, and for such term as may be prescribed by the By-Laws.

ARTICLE VII: The Executive Board of the corporation shall consist of the above officers and the Chairmen of Standing Committees. The Executive Board shall have control and management of the society's activities and generally supervise the affairs of the corporation.

ARTICLE X: The corporation as hereinabove provided shall have power to adopt By-laws for the regularion of its internal affairs and for all other purposes not inconsistent with the laws of the State of Alabama and with these Articles of Incorporation.

The following AMENDMENT TO THE CONSTITUTION was made on July 20, 1976, in order to qualify for a tax exempt status under Internal Revenue Code Section 501 (c) (3):

AMENDMENT: In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or Local government for exclusive public purpose.

Not withstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future united States Internal Revenue Law.

It had been so long since we first organized, several had asked that the Constitution and By-Laws be published. The By-Laws will be published in the June issue of this newsletter.
