

REGARDING THE ALABAMA HISTORICAL COMMISSION - Mrs. Carolyn Cagle of Montgomery, Legislative Chairman for the Board of Advisors of the Alabama Historical Commission has asked that the following news editorial published in The Enquirer and Ledger of Columbus, Georgia, be published. Two Board of Advisor members, Gordon L. Cooksey, and your editor's cousin, Mrs. Virginia Brannan Smith, both columnists, keep that newspaper up to date on historical happenings and events:

THE SATURDAY ENQUIRER AND LEDGER, Columbus, Ga., Dec., 1979 WRONG WAY PANEL - Accounts of this week's Alabama Historical Commission meeting carried the noises of a steamroller in the background.

Acting Chairman James Record, the chief architect of Director Warner Floyd's demise last year, rammed through approval of a new director whom none of the commission members had met. Objections were countered with Record's offer that the new director could be fired if he didn't work out.

Following this ramroad style of hiring were Record's dismissals of inquiries about investigations into thefts of department gasoline and a truck. Fortunately for Alabama, Record is no longer in charge of the commission. Former University of Montevallo President Kermit Johnson, a moderating influence, was elected to chair the group.

But the events of the last AHC meeting leave serious questions about the independence of the body, recently wracked with political pressures. Floyd lost his job trying to shield the commission and its work from this very same high-handedness.

Regardless of the interest or stated qualifications of the new director, who lives in Virginia, commission members should have had the compensation to interest or stated qualifications of the new director, who lives in Virginia, commission members should

have had the opportunity to interview him. Regardless of who was involved in the theft of gasoline and the truck, they should be exposed and punished.

For the AHC to regain its credibility, Johnson must resolve the criminal inquiries and set a direction for the commission.

Moreover, the board's members must assert their independence and refuse to be badgered by special interests.

Carolyn Cagle reports that a move is underway through Mr. Bob Davis, Administrative Director for the Governor, to have the Archives and Records Management Program for the state revamped. The archives is three years behind in cataloguing its papers, books andother items. Because of this fact, although Gov. Wallace had given his earlier papers and those of his late wife, also former governor, Lurleen Wallace's papers, he decided to have his papers from his last administration catalogued by a lady from Birmingham and will later make a decision as to where to house them. For years people over the state have complained and requested that Milo Howard keep the Archives open on Saturdays so that people can go there and do research without having to take valuable time off from work, but Mr. Howard turns a deaf ear or with a shrug pleads "insufficient funds" when only a little know-how in re arranging his present personnel and a little help from college students would solve the problem. Your letter of request to the Governor asking that the Archives be open on Saturdays would bring the desired results, as Mr. Howard will only open on Saturdays if he is forced to do so.

NEW ALABAMA HISTORICAL COMMISSION EXECUTIVE DIRECTOR: Above the protest of Lt. Gov. George McMillan who asked that a final decision not be made as to a new executive director until the four newly appointed members of the Commission had time to study the applications, then Chairman James Record called for a vote and F. Lawrence Oaks of Waterford, Virginia, 36 years of age and a native Alabamian was named to the post. Oaks has undergraduate and graduate degrees from the University of Alabama and continued study at Georgetown University in Washington and at the University of Virginia. Oaks, who is presently an administrative assistant in the Fairfax County, Va. public schools, with his wife and 7-year old son will move to Alabama in January. At the meeting Dr. Kermit A. Johnson, retired president of the University of Montevallo was elected as Chairman of the Commission.
