Topic - "BREWTON HIGHLIGHTS"

In carrying out her duties as Director of the Brewton Chamber of Commerce, Mrs. Pam Peterson has been the power behind getting the initial paperwork, histories of buildings, etc. together in attempting to have the Downtown Brewton Historic District put on the National Register of Historic Places. The District has been approved by the State Board and is now in Washington for final approval. Mrs. Peterson has also worked with the Chamber in having a new brochure to be entitled "Tour Historic Brewton" published for distribution by the Chamber. The brochure will depict particular architectural styles and esigns in homes as well as many other places of interest to visitors. A picture of the Thomas E. McMillan Museum will be included and information regarding the Genealogical and Historical Reference Center located in the museum. In her presentation she will tell some of the histories of the buildings and explain the different styles of architecture found in Brewton while showing pictures and slides. Pam's husband, Larry, is with South Central Bell Telephone Company and they, with their 11 year old son live on Spruce Avenue. Larry is originally from Tennessee and Pam is a native of Ohio. After coming to Brewton 12 years ago Pam attended and received a degree from Jefferson Davis State Junior College and in 1979 graduated cum laude from the University of West Florida. A question and answer session will follow the program. Come and bring a friend.

IN MEMORY OF E.C.BOYKIN AND WIFE, RITA AMENT BOYKIN E.C. Boykin was born at Boykin, Escambia County, in 1872 and died in 1945. He graduated from Mobile Medical School in 1892 in the same class as Dr. P.H.M. Tippins who also returned to Brewton to practice. He worked for Curry Drug Store for a time then travelled for Durr Drug Co.in Montgomery for some time and married there. He came back to Brewton with his wife in 1912 and from then on had a drug store until his death. He was always happy and had for his motto, "Work is not a drudge when you like it. " He helped people during the depression by accepting eggs, syrup and other farm products as payment for medicine. He had some of his own prescriptions and concoctions -- his own "1312 Rheumatism Medicine" was the best known. He served on the City Council and was a decon in the Presbyterian Church. His wife, Rita Ament Boykin, born 1888 and died 1964, was a native of Nashville and grew up in Montgomery. She was a housewife until his death, after which she kept the store for 11 years because she was needed to carry it on. She was active in the Presbyterian Church and help practically every office in the Women of the Church and taught Sunday School. She was a seamstress and made all her children's clothing. Their children were E.C.Boykin, Jr., Gideon (Gid), and Rita Jane.

IN MEMORY OF SAMUEL LEWIS McGOWIN 1859-1928 Mr. McGowin was the son of Feter McGowin and . Nancy Floyd McGowin, born 10/6/1859 at Boykin, Escambia Co., Al. died 9/29/1928 at Mason, Escambia Co., Al., married first Ada Bethea on 3/13/1881 at Brooklyn, and they had 9 children, after her death he married Madge Parker on 3/15/1894 at Roberts and they had 5 children. Samuel Lewis McGowin lived in the old Blacksher home at Mason until his death. Samuel Lewis McGowin was a County Commissioner, First District, from 1915 until his death. His father Peter Mason McGowin died on 12/19/1863 in a Confederate Camp out from Mobile and his widow went to Mobile and brought his body back for burial in the Foshee Cemetery near Grab Mill.
