We also hope to have many visitors who will want to view the Museum and Archives while here for the meeting. Plan ahead to be with us on Sunday, September 21st at 2:00 p.m.

WORK HAS BEEN GOING ON! During the last week John Powell, Museum Curator, has really put some hours and diligent effort into getting the Historical Society's valuable collection of area, Alabama, Mississippi, Georgia and Florida history and genealogical books, files, microfilm, documents, newspaper volumes, official courthouse records, etc. into the proper order again. Two additional office spaces have been allotted to the Museum Area for properly housing and displaying the Escambia County Historical Society's collection of reference materials. Proper directional signs will be placed in the entrance to the museum. All of the area history books have been conveniently catalogued and placed on the bookshelves in the Curator's Office. The Luttrell Hardware records and back issues of the Escambia County

Historical Society Quarters and newsletters have been neatly arranged on storage shelves in proper sequence, along with some of the courthouse records and placed in the office adjoining the Curator's office. Further down the hall in a larger office a microfilm reading room has been set up with the several cabinets of historical files belonging to the Society, the general history books, the old newspaper volumes and other official county records that were loaned to the Museum by the Escambia County Commission, the microfilm camera, microfilm reader, microfitch reader, and the microfilm census records placed in it. A small table has been provided also in the room for sitting to read the records, newspapers etc. Our Escambia County Historical and Genealogical Reference Center is now set up as a valuable archives of this type should be and we can be justifiably proud to send researchers and students over to the Museum for this purpose. Another 20 books have been donated to the Society this month. Soon our archives will be second to none for doing area research. We commend Dr. George McCormick and the college administration for giving us this extra space and John Powell, Curator, for the many hours spent in getting these valuable records set up in a manner befitting such a unique collection

- IN MEMORY OF SHERIFF E. S. McMILLAN, who was born in Santa Rosa County, Fla., Sept. 7, 1854. He removed with his family to Pollard, Ala. in 1870, and on attaining his majority began work with his father as a teamster, then as a clerk in the business house of McMillan & Wiggins. In 1884 he associated himself in partnership with C.L. Wiggins in a mercantile business in Pollard which he disposed of and engaged in the logging business. In 1890 he purchased a grocery store in Brewton which he conducted successfully. He was appointed Brewton City Marshal on Feb. 6, 1891, and later was elected Sheriff of Escambia County beginning his term on Aug. 17, 1892. He was subsequently killed in the line of duty by a black outlaw called Railroad Bill on July 3, 1895. His widow, Kate Leigh daughter of N.R. Leigh and Kate Burnett Leigh, and his two children, Ed Leigh and Malcolm McMillan, survived him. He was a faithful member of the Methodist Church and belonged to the K.of H., K.of P. and Masonic orders.
