family, the LANGTON family and the PROSS family.

My grandfather's name is Cecil Arthur Lionel Trevor George Herbert Gore-Langton. He was born on Aug. 25, 1882 at Newton Park, Bath, England. He married Julia Hope Sophia Kamakia Magoon on March 1, 1919 at Modesto, Calif., and died Feb. 25, 1925, at Honolulu, Hawaii.

Cecil Arthur's parents were possibly Lord William or Stephen Gore-Langton and Mary Ethel Pross and they were married

around 1880.

Mary Ethel Pross was the second wife of Lord Gore-Langton. Lord Gore-Langton by his first wife had two daughters: Lily Gore-Langton and Lena Gore-Langton.

Lord Gore-Langton and Mary Ethel Pross had two sons by

their marriage:

Cecil Arthur Lionel Trevor George Herbert Gore-Langton born in 1882,

Leonard Merton Gore-Langton born in 1884.

Now, when Lord Gore-Langton told his sons, that when they go to the United States, they can put the Gore-Langton name together or split it up and use one or the other. In other words, Gorelangton or Gore or Langton. My grandfather put the name together,

Now comes the problem. We do not know what happened to

Leonard, Lily or Lena.

Mary Ethel Pross was the daughter of Nathaniel Pross, who served in the Civil War on the South's side as a doctor and is rumored to have been in Jefferson Davis's Cabinet.
