ESCAMBIA COUNTY HISTORICAL SOCIETY WILL MEET MARCH 28, 2000 AT 3:00 P.M. IN THE THOMAS E. MCMILLAN MUSEUM LOCATED IN THE FINE ARTS CENTER OF JEFFERSON DAVIS COMMUNITY COLLEGE, BREWTON, ALABAMA.

<u>MARCH MEETING</u>. Kathryn M. Flynn, Extension Specialist/Associate Professor with the School of Forestry and Wildlife Sciences of Auburn University will be the guest speaker. She will discuss the Sepulga River from a

historical perspective as well as water quality issues.

The Sepulga River is a principal tributary of the Conecuh River. The Conecuh River traverses Bullock, Pike, Crenshaw, Covington, and Escambia Counties, Alabama for 235 miles and then the Conecuh River becomes the Escambia River in Florida where the remaining length is another 65-1/2 miles. (These mileage statistics come from the Story of Alabama, a History of the State by Marie Bankhead Owen). The Sepulga River enters the Conecuh River upstream from McGowin's Bridge, located on Highway 29, north of Brewton. The rivers provided transportation for transporting goods like timber, pumpkins, and cotton to Pensacola. In 1840, the USS Shaw, a side wheeler steamboat hit a snag and sank in the river after it had unloaded in Brooklyn, Alabama and reloaded with cotton and traveled downstream where it met its fate.
