Wes Hardin

Calling himself an artist by profession and an illustrator by trade, **Wes Hardin** lives in **Dothan**, **Alabama**, and has been painting murals since he was in high school. It was the quality of his **murals in Dothan** that convinced the **Brewton Tree and Beautification Board** that he should be the artist to do a mural for Brewton.

He says he became hooked on doing large paintings when he participated in a class project painting a mural in a mall in **Panama City**, **Florida**. His murals are really **illustrations of history**, as in the case of the one in Brewton, which tells the story of the logging industry, a primary part of the town's history.

He does interiors for private homes, as well as large murals on buildings and has painted for individuals and companies from **Florida to Washington D. C.** At the present time, he is working in **Andalusia**, **Alabama**, covering a large truck with a mural of scenes based on **Gone with the Wind**. The trucking company plans to use this "mural on wheels" as an advertisement for the company

When funds are available, the **Brewton Tree and Beautification Board** has plans for more murals by Mr. Hardin on Brewton's history.

The March Meeting

There was overwhelming approval of the amendments to the Society's By-Laws. Those attending the meeting unanimously agreed

- 1. That Section 3 of Article VI be deleted in its entirety.
- 2. That punctuation (a comma) be placed in the wording of Article VI, Section I, following the word(s) Historian/Curator and before the conjunction "and" in the phrase, "Historian/Curator and Editor of Journal and Newsletter," so as to clearly separate the two, distinct officer-positions.

3. That Article VI, Section 2 be amended to read, "Officers shall be elected biennially and shall hold office for a term of two (2) years, or until their successors are elected.

In other business, **President Darryl Searcy** presented our Treasurer, **Peggy Bracken**, with a Certificate of Appreciation in recognition for the **outstanding work** she has done in preparing financial reports for the society. In his remarks, Darryl pointed out that with little data to go on, she has tracked down information from agencies and individuals throughout the county and state to give the society a good financial statement. The **Society's President** said that **Peggy** "never gave up in the face of absolute adversity and frustration, when I really wanted to lay it down and walk away"; she "never doubted, and never quit smiling."

President Searcy also reported that questions concerning monies paid to Anita Enterprises have been successfully resolved with both the society and the accounting firm pleased with the results. Anita Enterprises has agreed to pay back \$150 of \$300 paid to them.

Peggy Bracken served delicious refreshments.

The News in 1906

From the **Brewton Standard** for April 1906

• Ex-Governor, William C. Oates, as a part of his campaign to be Alternate U. S. Senator from Alabama, spoke at the courthouse in Brewton. He pledged that, if elected, he would "fight for a measure refunding to the Southern States the amount of money which was forced from them in Reconstruction days by the iniquitous cotton tax."

- Ex-Governor Russell M. Cunningham reopened his campaign for Governor at the Auditorium of the Brewton Institute. He declared he was in favor of the "healthy immigration of a good class of citizenship, which would add to the number of our better element of citizens and thus be a benefit to the state."
- Robert Bell, M. C. Stokes, C. W. F. Price, Nicholas T. Dixon, W. K. Mayo, and G. K. Fountain announced they were running for sheriff of Escambia County.
- The County Commissioner's Court agreed to a petition from the citizens of Brewton to have the county buildings on St. Joseph Ave. moved back ten feet.
- The Commissioners also appropriated \$250.00 for the installment on the courthouse grounds of two large cannon, which were given to the county by the federal government.
- The Grand Jury of Escambia County reported that they had examined the condition of the county roads and found that "a marked improvement could be had if the officials in charge thereof would be more diligent in the discharge of their duty." The Grand Jury also reported it had found the courthouse and jail properly kept, the county's books in good order, but did not inspect the county poor house because "there were no papers in it."
- Dr. L. E. Ray & Co., "The great southern specialist of Louisville, now located in Brewton," advertised treatment for all chronic diseases, promising he, "Cures Catarrh in from 30 to 60 days." Costs were only \$3.00 to \$5.00 per month.
- Calhoun, Florida, was on a boom, "There was a wedding, a log rolling and a school exhibition," all in one week.
- The Lindsey Lumber Company in Pollard and the Depot at Flomaton were destroyed by fire.
- At Bradley, Mr. George Stephenson was rebuilding his saw, gristmill and gin that had been destroyed by fire a few weeks earlier. The whistle had blown the day before and the mill would "commence sawing again" the next week.
- Southern Bell Tel & Tel installed a new switchboard for 100 more telephone lines in their Brewton office, the second board installed within a year. The manager reported there were 125 phones already installed in Brewton, with phone lines in place to Alco and North Brewton, and plans to extend the lines to East Brewton.
- Also, Southern Bell put in a pay station in the Brewton Drug Co., "for the convenience of the patrons of the Long Distance."

- The L. & N. Railroad announced it was putting in a new spur track from the switch at Simmons and Mill Streets to run to the log road of the Lovelace Lumber Co. The new spur would handle the shipments from the fruit farms north of Brewton.
- Cement blocks were used to pave the sidewalk in front of the new Brewcambia Hotel and Mr. W. T. Neal had the sidewalk "across the entire front of his residence lot laid."
- The Lovelace Lumber Co. announced it would no longer sell or deliver wood on account: "Parties desiring wood must pay drayman on delivery."
- Sowell and Hayes installed a modern electric message machine, making their establishment "as up-to-date as any found in the cities of many thousands."
- Mrs. Alabama Debardeleben was the guest of Mrs. W. G. Martain at Rose Fern Cottage.
